- Remember the county just purchased 25 acres for \$30,000 last year. Eight of our elected public servants received a \$4,800 pay raise two years ago cost us \$38,400 per year. When Ed Corbitt retired, he was not satisfied with the amount of his retirement and the county commission bumped him up to a dollar amount where he would be unable to receive another penny and we are still paying the difference every year. The \$4,800 pay raise was a scam. Initially, the money was for the four commissioners as an expense allowance for not having a county vehicle.
