Dear Chairman Maxwell,

Clean hands<sup>1</sup> is the principle that  
always works best for all parties concerned.

During public comment on September 13, 2021, I hand delivered to you a Statement  
of Facts concerning personal farm vehicles and equipment and commercial vehicles  
on county property being serviced and maintained by county employees during  
normal working hours using county equipment, tools, and lubricants.

A request for Open Records was a component of the September 13, 2021 letter.

To date, I have not received your response.

I am writing for the second time to afford you the opportunity provide the requested  
public documents and for you to correct or dispute any of the facts stated in the  
September 13, 2021 document, as it contained,

“Clean hands<sup>2</sup> is the principle that always works best for all parties concerned.

Declaration of facts and Open Records request.

This is my third submission of my State of Facts concerning personal and commercial equipment stored and serviced by county employees within Hwy 199 Road and Bridge compound. If you choose to clarify, rebut, or dispute these facts, please do so by mailing your comments to 2273 C.R. 54 West, Notasulga, AL 36866 by Wednesday., April 20, 2022 or the facts will become Undisputed Facts.

I want a copy of the county's invoice for the purchase of this photographed bulldozer and John Deere tractor within the next 10 business days following receipt of this letter, or September 27, 2021.

In a letter to you, Mr. Jimmy McGhar attached a copy of a business seal on the side of a dump truck, leaving the compound in the evening after normal working hours. That truck was also parked under cover on the Road and Bridge complex.



It appears that personal equipment has been and is on the Road and Bridge compound and possibly being serviced and repaired by county employees.

In his letter, McGhar stated that Russell Berry called him that evening inquiring why he was following his dump truck, which was followed by McGhar exiting county property after routine working hours.

I look forward to your response by September 27, 2021.

Respectfully, reserving all rights, known and unknown, and waiving none.”

You have sworn to support the Constitutions of the U.S. and Alabama and to “faithfully and impartially perform and discharge the duties of the office to which I am about to enter, so help me God.”

Alabama Open Records Act §36-12-40 which provides “[e]very citizen has a right to inspect and take a copy of any public writing of this state, except as otherwise expressly provided by statute.

Having sworn to “perform and discharge the duties” of Chairman, Macon County Commission, which includes the responsibility to either provide the requested document or a justification of denial.

“[B]ecause there is a presumption of required disclosure, the party refusing disclosure shall have the burden of proving that the writings or records sought are within an exception and warrant nondisclosure of them,” [and] “[t]he Stone exceptions were not intended, nor shall they be used, as an avenue for public officials to **pick and choose** (emphasis applied) what they believe the public should be made aware of.” **Blankenship v. City of Hoover, 590 So. 2d at 245 (1991)**.

I look forward to, should you desire, receiving your written comments and disputing any of the above facts and the requested public documents in compliance with the Open Records Act and case law at 2273 County Road 54 West, Notasulga, AL 36866 by Tuesday, March 29, 2022.
